Nazarian said she would like to make an announcement that in 2023 the town applied for a Crest Grant for infrastructure projects on the small size and they applied for the Prior Road Bridge for \$150,000.00 and the Town was awarded that amount and we have \$58,000.00 in reserve.

JoAnn Nazarian: Huntley Rd - Negative Declaration

Nazarian said a month ago we started the SEQR process for Huntley Road District that process has been completed and accept parts two and three of the full SEQR Assessment for Huntley Road Water District. Nazarian we have a Resolution determine that the proposed Town of Schroeppel County Route 57 and Huntley Road Water District. Nazarian said the finding are that it was negative and there is a negative impact on the work that will have to be done. Huntley Road Bond:

Nazarian said also part of the County Route 57 and Huntley Road Water District she would like to make the **Motion** to pass the Bond Resolution dated June 11th 2024 of the Town of Schroeppel, New York authorizing the undertaking of certain capital improvements at an estimated maximum cost of \$2,795,000. and authorizing the issuance of serial or statutory installment bonds in an aggregate principal amount not to exceed \$2,795.000. of the Town pursuant to the Local Finance law to finance said purpose, authorizing the issuance and sale of Bond Anticipation notes in anticipation of the sale of such bonds and delegating the power to issue and sell such bonds and notes to the Town Supervisor seconded by Gelling. WIIA Grant:

Nazarian said we have a Resolution to submit NYSEFC WIIA Funding application. Nazarian said whereas the Town desires to make application to the NYS Water infrastructure Improvement Act for the County Route 57 and Huntley Road Water District to seek financial assistance.
