## **SEQR Motion:**

Gelling made a **Motion** that all actions taken tonight are excluded, exempt or Type II actions for the purpose of the State Environmental Quality Review Law unless otherwise stated, seconded by L. Hoyt. All aye Nazarian, Gelling, L. Hoyt and Redhead. Absent N. Hoyt

At 6:02 Nazarian re- opened the Public Hearing on the 2022 Town of Schroeppel Comprehensive Plan and asked if there was any more public comments on this? No comments. Caraccioli went over the Environmental Review and issue a no negative declaration which there are no negative impacts on the environment and in this case it's the entire Town of Schroeppel. Caraccioli said there is a motion included in the Resolution to adopt the Comprehensive Plan which again is a revised from the other one that has been in effect over 20 years and has been worked on over a years with the Planning Board and Saratoga Associates. Caraccioli said the Town Board received for SEQR purposes part 2 of the full Environmental Assessment form there are a number of impacts that have to be looked at on Land, Geological, Impact on surface water, impact on ground water, flooding, air, plants and animals Agricultural Resources, Historical and Archeological, opened space and Recreation, critical environmental areas, transportation, Energy, noise, order, light and human health, consistency with Community Plans and with Community Character. All those things have been looked at by the Town Board it is the recommendation of the staff which includes the Saratoga Associates, Planning Board Members and himself that the Town adopt a negative declaration which is contained in part 3 full Environmental Assessment form. Caraccioli said the Comprehensive Plan is a road map for future development. The conclusion and recommendation of staff be a negative Declaration that the project in this case adopting the Comprehensive Plan will result in no significance adverse impacts on the environmental and therefor environmental Impacts statement need not be prepared accordingly a negative Declaration be issued and that's the nature of the SEOR analysis and that is the nature of the Resolution that has been prepared. Caraccioli read the Resolution. (Attached to Minutes) Nazarian thank the planning Board and Saratoga Associates for all their hard work, (Attached to Minutes) is the Full Environmental Assessment Form Part 2 – Identification of Potential Project Impacts and Full Environmental Assessment Form Part 3 – Evaluation of Magnitude and Importance of Project Impacts and Determination of Significance)
