At 6:00 p.m. Redhead called the meeting to order with the Pledge Allegiance.

SEQR Motion:

Redhead said Councilmen Nick Hoyt, Councilmen Lewis Hoyt, Councilmen Zachary Gelling, Councilwoman JoAnn Nazarian, Supervisor Cary Redhead and Town Clerk Darlene Owens were in attendance for the Town Board meeting.

Cary Redhead: Signatory on Town Accounts

Redhead said she had sent letters to M&T Bank to Julie Appley for Global Administrator, Treasury Management to add Brenda Weissenberg and remove Cary Redhead and to add JoAnn Nazarian as 1/1/2024. Wire Contracts to remove Cary Redhead and add JoAnn Nazarian and keep Brenda Weissenberg on. Gelling made the **Motion** to accept the change seconded by L. Hoyt. All ayes: Nazarian, Gelling, L. Hoyt, N. Hoyt and Redhead.

Budget Change

Redhead said there was a change in the Adopted Budget and that the Highway Superintendent salary was \$73,313.07 and it was changed to \$70,713.00.

JoAnn Nazarian: NYS Parks, Recreation and Historical Preservation

Nazarian said the Town was notified the town did receive the NYS Parks, Recreation and Historical Preservation Grant for the park \$500,000.00 in which the town has to match the same amount that they use. Starting next year we will be working on updates for the park.

Highway – Letter of Intent

Nazarian said she had the letters of intent for a 2025 International HX620SBA 6 x 44 with a Viking Cives Plow Body Package for a total of \$250,802.40 and so we request it now will probably won't get it until 2025 or 2026 and that is when the first payment will be do. Nazarian made the **Motion** to accept the amount at \$250.802.40 for seconded by N. Hoyt. All ayes: Nazarian, Gelling, L. Hoyt, N. Hoyt and Redhead.

Nazarian said the 2025 International HV607SBA LP Bucket Truck with an Altec Aerial Device Package the approximately \$262,219.00 and Hoyt said it will be up to \$2,000.00 more than the quote. Nazarian made the **Motion** to accept 2025 or 2026 International HV607 SBA LP not to exceed \$265,000.00 seconded by Redhead. All ayes: Nazarian, Gelling, L. Hoyt, N. Hoyt and Redhead.

Animal Shelter Grant

Nazarian said that the Animal Shelter Grant is back open. It opened November 6 2023and the due date is January-29 2024and because we are a municipality of under 2 million people we could request funds not less than 50,000. But more 200,000.00 and the town would only be responsible for 10% of the total cost to any updates renovations new construction expansion of buildings, equipment and facilities. Nazarian said she would like to apply for the grant and would like to get started right away. Nazarian said she reached out to C2AE and C&S for a quote and she knows we need three. Nazarian said to go with Barton & Loguidice. N. Hoyt said if it's 10% of the cost go for the max. There was discussion on the dog kennel leach field.
